Instructions

To apply for election or appointment to the Ocean Beach Planning Board, complete this form in its entirety. In addition to the requirements below, all candidates must gather at least 35 valid signatures from the district in which they are seeking election/appointment; use pages 2-3 to collect signatures. Applications for appointment (rather than election) may be for a district other than the candidate's home district.

To be eligible, candidates must have attended at least one of the Board's last 12 meetings prior to the election. Additionally, candidates must demonstrate that they are 18 years of age and meet one of the following conditions within the Ocean Beach Community Plan Area (*refer to map on page 4*) for more than 30 days:

- **Resident:** Residing and maintaining a physical address.
- **Property Owner:** Owning property.
- **Business Owner/Licensee:** Operating/owning a business with a physical address/location.

(Proof of the above may be established with a copy of a driver's license [or other government ID] in addition to a copy of a utility bill, business license, or tax bill that demonstrates the qualifying address of the candidate.)

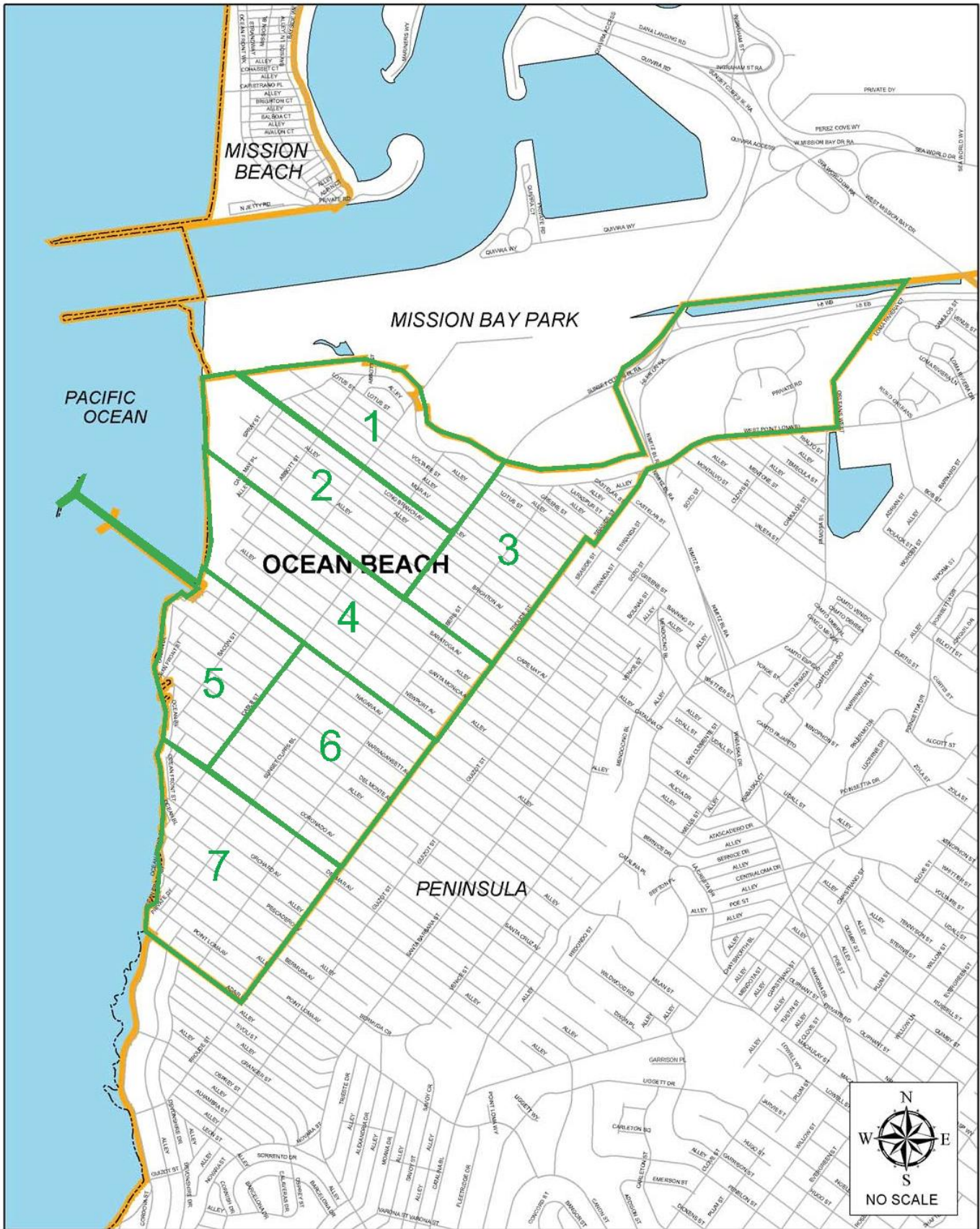
