VOTER ELIGIBILITY

To vote in the OBPB election you must show proof that you are:

- At least 18 years of age
- A **resident, property owner or business licensee/owner** within the OB Planning Area for **30 days or more**. *Proof may be established with a copy of a driver's license or other government ID in addition to a copy of a utility bill, business license, or tax bill that demonstrates the qualifying address of the voter.*
- NOTE: It is not necessary to be a state registered voter.
