Subject: Proposed Overnight Parking Lot Closures and Strategic Management Plan

To Whom It May Concern:

The California Coastal Commission (CCC) has requested that the City of San Diego (City) determine if public interest remains for securing overnight certain parking lots located along the shoreline and in Mission Bay Park. As a stakeholder group located within a community adjacent to the coast, this letter requests you consider whether your organization supports or opposes the installation of security gates at its shoreline parks to improve public safety and reduce illegal activity.

The City historically has had overnight gate closures and signed overnight parking restrictions for over 20 years at multiple locations, including (from north to south):

- La Jolla Shores Kellogg Park gate closure nightly
- Tourmaline Surfing Park signed no parking nightly
- Belmont Park/Mission Beach South signed no parking nightly
- South Mission Beach signed no parking and gate closure nightly
- Ocean Beach Dog Beach Lot Restricted Hours: No Parking 2am-4am
- Ocean Beach Santa Monica Lot signed no parking nightly
- Ocean Beach Newport-Pier Lot signed no parking nightly
- Sunset Cliffs Linear Park signed no parking nightly
- Sunset Cliffs Ladera Lot signed no parking nightly
- South Jetty/ Mission Point Gate closed daily by contractor
- Crown Point gate closure nightly
- Fiesta Island gate closure nightly
- Fanuel Park gate closure nightly

Based on recent observations of after-hours activity and requests made to secure those areas at night, the City is considering additional locations for consideration for overnight closure as follows (from north to south):

- Torrey Pines City Park and Gliderport proposed gate closure nightly
- Belmont Park/Mission Beach South proposed gate installation closure nightly
- Ocean Beach Dog Beach proposed to be signed no parking nightly
- Ocean Beach Santa Monica Avenue Parking Lot proposed to be signed no parking nightly
- Ocean Beach Newport Avenue and Ocean Beach Pier Parking Lot proposed to be signed no parking nightly
- Sunset Cliffs Linear Park proposed to be signed no parking nightly
- Sunset Cliffs Natural Park/Ladera Street Parking Lot proposed gate closure nightly
- East Bonita Cove proposed gate closure nightly
- · Ventura Cove proposed gate closure nightly
- · Bahia Point proposed gate closure nightly
- · Windansea proposed to be signed no parking nightly

A list of proposed additional locations for gate or signed overnight closures is provided in Attachment 2 and Attachment 3 outlines the City's Outreach Plan.

The City invites your organization to provide input on whether the City should continue to lock gates and restrict overnight parking at these locations, whether the City should propose to lock gates and restrict overnight parking at additional locations, and whether any other coastal and bay parks should be considered for implementation or removal of restrictions.

The City also welcomes your input on closure and opening times for restricted parking lots. This would include your organization's recommendations on times at which gates are closed and reopened daily, and it would also include desired timeframes for overnight signed parking lot closures at these sites. Your organization may also recommend other locations not currently on the City's list for possible consideration of parking lot closures including installation of gates and/or signs. Please note that gate installation is limited by available funding.

To be part of this effort, staff welcomes your organization's input and would appreciate a letter from your organization that outlines your support or objections to the gate closures and overnight signed parking restrictions.

The CCC will likely require Coastal Development Permits (CDPs) to secure parking lots for three-year terms. To demonstrate community input and consideration of these proposals, City staff will incorporate your organization's letters into a larger package that City staff will submit to the CCC. Date: June 25, 2021

Goal: The Parks and Recreation Department (Department) desires to obtain

input from beach community organizations to determine whether overnight parking restrictions can help reduce crime, reduce the fear of crime in beach communities, and therefore improve the quality of life

for residents and visitors to San Diego.

Strategy: The Department would bring an action request forward to the

California Coastal Commission to obtain permission to install and operate nighttime gates and signage to clear and close parking lots to reduce the number of illegal activities in the beach and bay areas that

have had increased criminal activity and reduced public safety.

Assigned Staff: Andy Field, Director

Michael Tully, Deputy Director Paul Jacob, Associate Engineer

Areas of Concern: The Department desires to address the problems associated with gang

activity, overnight parties, and illegal camping/fires in and around parking lots in Peninsula, Ocean Beach, Mission Beach, Mission Bay

Park, Pacific Beach, and La Jolla.

Timeframe: The Department would conduct outreach to various community

organizations between June and September 2021. A California Coastal

Commission package would be routed around November 2021.

Background: The parking lots in coastal parks (Sunset Cliffs, Ocean Beach, Mission

Beach, Pacific Beach and La Jolla) and several in Mission Bay Park routinely attract large numbers of illegal campers, gang members, and

large parties.

Gangs:

- Crimes against persons assaults/shootings
- Intimidating
- Cruising
- Violent crimes
- · Vandalism/tagging to park facilities
- · Vandalism to other vehicles

Misuse of City Property:

Overnight Parties:

Intended Outcomes: Key outcomes include:

- Reduction in crime and calls for service
- Deterrence of gang activity, overnight parties, and illegal campers
- Improvement in feeling of safety for park patrons, nearby residents, and visitors to the parks

Proposal:

Generally, the proposed hours of closure would be from 10 p.m. to 4 a.m. or midnight to 6 a.m. with gates to be closed by security service nightly. This may vary from park to park.

Installation of gates at any location is contingent upon availability of funding to install gates.

<u>Stakeholder Review and Consideration of Request</u>. Once notified, each community stakeholder group would consider the proposed gate and sign locations and would notify the Department in writing of its recommendations.

<u>Permit Application Process</u>. The Department would apply for permits from the California Coastal Commission with stakeholder letters attached to the application.

<u>Gate and Sign Installation.</u> If the California Coastal Commission approves, the Department would develop appropriate signage, examine feasibility and funding for gate installation, and determine appropriate implementation dates for each location.

Fiscal Impact:

San Diego Police Department: If gates and signage are approved, SDPD would see a reduced volume of calls for service in the impacted parking lots.

Parks and Recreation Department: Increased costs would be associated with sign replacements, security contract to lock and unlock gates, and installation of new gates if approved.
