

Candidate Application Instructions

ELIGIBILITY: All persons who meet the eligibility criteria below may apply to be a Board Member.

- Candidates must be 18 years of age.
- Are one (1) of the following: **Resident, Property Owner/Agent, Business Owner/Licensee**, within the OB Community Plan Area (see below map), for more than 30 days.
- It is NOT necessary to be a registered voter with the state or county government.

GATHER SIGNATURES: Obtain **20** signatures from within the Ocean Beach Planning Board Area.

- Signatures must be obtained from residents, property owners, or business owners/licensees within the Ocean Beach Planning Area (see map).
- Signatures must be submitted with the candidate application.

SUBMIT APPLICATION: Submit via e-mail to: elections@oceanbeachplanning.org or by mail to:
Ocean Beach Planning Board, 4967 Newport Avenue #133, San Diego, CA 92107.

- To be listed on the election ballot, your application & signatures must be received by **February 6, 2024**.
- After this date, you may still run as a write-in candidate if your application & signatures are received by the conclusion of the Board meeting on March 6th, 2024.
- Applications & signatures for election will **not** be accepted after the March 6th, 2024 Board meeting.
