A Process 2 Coastal Development Permit (CDP) to demolish an existing garage and construct an
additional three (3) story unit addition, interior remodel, Companion Unit, and encroachment(s)
totaling 5,703 square feet located at 4768 Del Mar Avenue. The 0.16-acre site is in the RM-1-1
and Coastal Overlay (non-appealable) zones of the Ocean Beach Community Planning area. This
is an expansion and remodel with the addition of a companion unit.

 following project completion. The second unit of the project will become a rental unit.
