No board action is required. Based on an in-depth analysis, The Ocean Beach Community Planning area loses a dwelling unit every 3 days, and a resident every 36 hours due to the recent trend to rent dwelling units out to transient residents. This use is considered illegal by City Attorney Mara Elliott, the Pacific Beach Planning Board, the Ocean Beach Planning Board, and the San Diego Community Planners Committee based on the existing San Diego Municipal Code.
