Trying to break up the 50 foot lots and thinks they are running up on the codes.

- Julie Klien made an announcement about Grom Fest that will be occurring during the month of August. All youth surf competition for 92107/92106 residents.

ACTION ITEM #1: FUTURE TARGET STORE 4926 NEWPORT AND ADDITIONAL OFF-SALE ALCOHOL PERMITS IN OB

John recapped the even timeline with Target. Will be deciding if off sale alcohol permits should be given to any people seeking them.

Owners of the property: 24 years ago they bought building opened the antique store. There were negative comments about it then too. Have been involved in the community. The property is 18,000 sq ft. Was hoping someone would buy the antique store and maintain it. However antique stores are struggling. Didn't want to sub divide it.

Lori Jones development manger with Target oversee community outreach ahead of opening a store spoke:

- Said she had reached out to the community leaders, district 2, Ocean Beach Planning Board, Ocean Beach Town Council, and the Ocean Beach Main Street Association to have an open discussion about what the community could need in a Target retail space.
- Small format Target store aim to help communities stay within walking distance to get their essential needs. Every small format store is aimed to be tailored to the community.
- Will be looking to lease the location and reinvest.
- Will be remodeling the outside of the building but will try and go along with the look on newport avenue. Want to hire from the community.
- Two trucks 28 ft trailer coming once a day.
- Believes the community needs a store that sells home decor, domestic items, computer ink cartridges, men and children's clothing are some of the needs that they think should be met. prepared to open the store without alcohol.
- The store will not have a Starbucks or a pharmacy.
