Senator Toni Atkins - Chevelle Newell-Tate

Brought Toni Times. Women's history month. Budget forum Thursday, March 28th allowing community participation. Recycling - 6 different convenience zones were impacted by the closing of Prince Recycling Center in Point Loma. There are a handful of business that are paying the fine of \$100 per day and some that are now 18 implementing a buy back program in store. Josh (councilmember's office): Still in information gathering phase. May come before Council April or May. **AS:** now is a great time to get in public comments.

Public Comment:

Frank Gormlie: Doesn't limit the numbers. The fee and licensing is not a great deterrent. More injuries are coming into focus. People are not wearing helmets. ER visits are growing from accidents. Police have had a huge uptick in citations.

Board Comment:

AC: same sentiments. Hazard to sight impaired. How much tax revenue is going to city and where is it going? **DD:** dangerous and has been hit by a scooter. **LF:** limit the amount of companies **AS:** are you looking at other cities ordinances. **AS/Josh:** permits are being looked at. Every six-month. Permit fee vs per device fee? Permit: Development Services money for general functions, Device: mobility fund for streets, infrastructure. **CK:** permits for public right away where any other company has to get a permit. 4 hour pick up and impound or else a hefty fee. **JG:** agree with Frank. Users are not following street laws. VW: limited to a certain number and enforcing traffic laws and staging and drop off locations. **AW:** huge proponent of last mile. Limit to 1-2 vendors. Geofencing. **TD:** what is the mayor trying to regulate,

scooters, bikes or both? Maybe look at different legislation for them separately. No staging at corners: limits visibility and safety. OB is not in geofencing plan. Permit for public right away sales. **AS:** presented bullets from the Mayors plan. Permitting, Data sharing. Read that the scooters have small margins. 12-16\$ per day per scooter with a lifespan of less than a month. Creating a lot of waste. Since the system is run by AI the companies know when they are damaged and should be picked up. Sunset Cliffs should be geofenced. **VW:** wants the companies to address the waste issue, end of life when they need to be removed and picked up without abandoning them. **AS:** not requiring a helmet was shortsighted. **AW:** encourage drop or staging is areas where they would be most useful and not spread out everywhere.
