<u>INFORMATION ITEM #1:</u> West Point Loma Blvd. Road Diet Options (recording time 1:21:14)

A presentation was given regarding the West Point Loma Blvd road diet, parking changes and cycle track bike lanes.

Board and Public comments/concerns: Parking elimination? Some don't feel that we're ready for this yet as there is not enough bicyclist traffic to require it. Lessoning the lanes but adding more housing seems short sighted. Major traffic jams. Not looking at all possible options. The timing was going to work because the road will be repaved and repainted so why not repaint it to accommodate bike lanes. So essentially, if it doesn't work, it's just paint and can be redone. Speed limit is going to decrease once lanes are reduced. Turn lanes will be left alone. To mitigate resident parking loss - maybe use Barnes Parking lot for residents. Residents are afraid to cross the street.
