The Board reviewed parking studies for the main parking lots in Ocean Beach. Council office will be looking at options and discussing ideas that the Board suggested. Public members who spoke are in support of mitigation and enforcement. Board members discussed many different options and ideas but unanimously supported implementing parking mitigation.

**Motion AS/KH:** OBPB would like to request the following priorities: Overnight enforcement 12-5, Installation of locking gates, 4-hour limit in beach lots, hybrid paid option

#### ACTION ITEM #3: Del Monte Street Overlook https://youtu.be/daEPC Vy35Y?t=6629

The City has asked the board to consider whether the overlook on Del Monte overlook at Guizot should be permanently closed to parked cars.

History is that the community has placed bollards to prevent automobile access to the overlook. They believe that allowing autos to pull up and hang out has encouraged nefarious activity in front of their property. City reached out to us to see if we would support the bollards becoming permanently or if we would like the area to continue being accessible by vehicles. It was also noted that this area is within the Peninsula Community Planning District but the City asked us because it is also located at the edge of Ocean Beach Planning Board district.

Many board members were in support of creating a barrier to prevent cars from accessing the space. Some were in support of turning the area into a pocket park. Others were against closing it off due to the fact that it is a public space and the felt as though it was a private taking of a public space, and some were concerned about the precedent of that happening. Another thought was that turning the area into a park would bring different types of issues to a park in regards to homeless and vagrancy.

Motion KH/NS: Move to relocate vehicle barrier 15' back and narrow driveway easement to 10'. This will allow room for vehicles and more safe space for people to use the space. And add benches.

AS Friendly Amendment: add, "with the intention of that space being maintained as a pocket park"

## ACTION ITEM #5 (Consent #1): Traffic and Bike Improvements on Nimitz Blvd. https://youtu.be/daEPC\_Vy35Y?

Motion to ask the City to evaluate for a protected Class 1 or Class 4 bike lane and dedicated right hand turn lane to go west on West Point Loma Blvd. from southbound Nimitz Blvd.

Community members have reached out about cars driving into the bike lane to make left turns. Tracy Dezenzo showed the area under consideration and discussed the need for dedicated turn lane. Members discussed and supported the motion recommended by the Parks Committee.

Motion AS/TD: Ask the City to evaluate for the addition of a right-hand turn lane on south bound Nimitz, turning right onto West Point Loma Blvd. with the inclusion of a class 4 or class 1 bike lane which ever is safer for the bikers.
