Action Item #1: CIP List and Prioritization

The board finalized its list of CIPs and their prioritization. The following list was presented to the Board with their priority numbers:

- Priority 1: Pier retrofit or replacement including addition of marine education center, wave energy capture, improved bathrooms, extend stairs down to the beach
- Priority 1: Lifeguard / Police substation tower including safe, monitored and ADA compliant restrooms
- Priority 1: OB Library expansion and upgrade
- Priority 3 ADA access paths/mats to the shoreline in the following locations: Dog Beach, Volleyball courts off Spray Street, Lifeguard tower area or Saratoga Park, Cape May
- Priority 4: Storm drain repair and retrofitting to address flooding and sea level rise
- Priority 5: OB Rec Center improvements
- Priority 5: OB Parks: Saratoga Beach Park, Spray St Park (Brighton Ave), Veteran's Plaza, and Ebers St Park improvements previously requested in our recent parks proposal
- Priority 6: Estuary project: Fencing to protect wildlife from pedestrians and canines
- Priority 6: Rebuild/replace the public access stairs south of the pier up to Niagara/Narraganset alley

Laura Dennison: Are you talking about the wooden stairs or the concrete stairs? **KH:** Wood stairs. It's all public right away. **LD:** Allen Keebler owner of Silver Spray. Has anyone contacted him? **KH:** It's public property and he doesn't have a say.

Action Item #2: Replacing Car Parking with Bicycle Parking

The Transportation Committee voted 6-0-0 to support the 2020 land development code update specifically for Municipal Code Section 142.0530 in Chapter 14, Article 2, Division 5 - Parking regulations, Table 142-05 F, the Ocean Beach Planning Board Transportation Committee supports the update to replace minimum parking requirements with bicycle parking at a ratio of two bicycle parking spaces for every 1 vehicle parking spot. This item was tabled from the July meeting due to time constraints.

Andrea explained that this was a code update and that it will be coming up for vote in October.

BOARD COMMENT:

VW: Seems like you could have more than 2 bikes in a space. How did they decide on only 2? AS: we don't know

KH: Thinks this has been misrepresented. Read through the code update and it was very clear that it would allow a bike rack on public/private property or even count one that already exists somewhere else and not even on their lot. Could obliterate parking and expand tables into parking spaces. There is no language for restrictions. Not aware of a lack of bike parking. Seems to be a developer/business friendly proposition. The Board has always fought against removing parking. Doesn't think the board should support this and should fight it. It will restrict access.

CK, JG, and RM: Agree with Kevin

TD: Was presented without these additional stipulations to the Transportation Committee. As Kevin pointed out, the spots they remove don't have to contain the bike parking because the parking can be represented by another bike rack that is a certain distance away from the parking stall. Which means they can remove parking and not even have bikes parking there. Only way I would support this, is if we request that the removed spot must be used for bike parking?

AC: Agreed with TD, must contain and must be used for bike parking

CK: You can get at least 4 bikes in a space. Would only support this if it allowed for a greater number of spaces AND only allow 1 space for bike parking.

KH: Is unsure what type of businesses this would impact.

AC: Interested in the code. Can you send it?

CC: Couldn't find anything on it. Would defer to Transpo but sounds like they don't support it anymore.

Board members made suggestions that only one parking spot could be converted and that the removed space must contain the bike parking on the premises.

PUBLIC COMMENT:

Luke Yarnall: in support of this action item. Would make it more inviting for biking.

From chat:

Susan Booth: I'm disabled and must drive to go anywhere. I wish there were more parking spaces set aside for the disabled.

Vmawi: That answers my question!

Mandy Havlik: Great points Kevin.

Nanci Kelly: I agree - it sounded good until Kevin explained - my thumbs up just went down

Luke Yarnall: I would challenge the assumption that more parking is always a good thing. A parking space that serves one person as they are parked for several hours, whereas a bike rack or outdoor seating can serve many people in the same time period. Moreover, people only drive so much on Newport or Voltaire because they think they can find parking there. Less parking creates a better environment for all of us walking and biking and skating there. Even with Kevin's comment I still support the action item. Thank you for your consideration.

Action Item #3: Roundabouts on West Point Loma Blvd.

The board will decide whether to ask for a traffic study to be done on West Point Loma Blvd. to evaluate for 3 roundabouts at Ebers St., Cable St., and Abbott St.

BOARD COMMENT:

AS: Request to remove Cable because of busses may not be able to go around a roundabout.

AC: Would like to get the traffic study done so we don't have to keep going back to the drawing board or hearing anecdotal info.

GM: Ebers has a traffic light. AS: There is no traffic light there.

KH: Wants to agree with AC but the City decided that Bacon would work and doesn't trust the judgement based on the singular roundabout decision. Agrees with TD that they work better in groups, but he doesn't trust the city to make the call.

VW: Study that encompasses the whole length of WPL and give recommendations to the entire street.

CC: Separate than Froude? AS: No. Separate study. CC: Is supportive of the whole length of WPL.

CK: We need a carefully drafted motion. Roundabouts at all intersections?

TD: Not in support of the singular roundabout at Bacon/WPL but am supportive of Abbott, Bacon, Cable and Ebers. Sunset Cliffs too but not sure if we could include it since it's so busy. Some feedback on OB Rag, suggested that if we don't do WPL/SC and Voltaire/SC then it wouldn't be effective. Not necessarily about traffic flow and movement, it's about safety, slowing the traffic. WPL is dangerous: curved, blind spots, hard to cross the street we need to slow the street and mitigate the traffic. Make this street safer. 100% in favor of requesting a traffic study to evaluate the entire length of WPL.

VW: Once the study is done that the City gives us recommendation for the combination they suggest.

PUBLIC COMMENT:

From chat:

Susan Booth: A roundabout at Ebers and WPL would not be good solution. It is a T-intersection with a stop sign on Ebers and no stop signs on WPL so the traffic on WPL flows past Ebers without any major problems. I live about 800 feet from that intersection and drive through that intersection several times a day. A roundabout at this intersection would slow down the flow of traffic. I like the idea of crosswalks with the flashing lights like the one on Chatsworth and Browning that was installed a couple of years ago.

AS/TD Motion: In support of vision zero, the Ocean Beach Planning Board would like to request a traffic study be done along the length of West Point Loma Blvd. between Abbott and Ebers to decide which traffic calming measures would be best, including but not limited to roundabouts, pedestrian crosswalks or other traffic calming measures.
