- Dog Beach:
 - CIP B19000 Accessible, project complete
 - New ramp constructed.
- End of Newport ADA Improvements:
 - CIP B18027 Accessible, design to start FY23
 - o ADA access on North end by Veterans Plaza
 - ADA access past the pier on the South side
- OB Municipal Pier:
 - o CIP S20011 Completed
 - Current repairs to rail. Emergency structure repairs
 - 8.4 million state grant
- Silverspray Alley Stairs:
 - No city activity
 - OBPB budget request
- Old-Salt Pool Access Stairs:
 - o CIP B22012 limited access, in the planning phase
 - Filled cave made by damage with new concrete
 - City will use existing permit documents
- Narragansett Ave. Existing Stairs:
 - o CIP B18026 Access, replacement design starting FY23
 - Temporary new handrails
 - Not seen by planning board yet
- Santa Cruz Ave. Access Stairs and Path, design starting FY23:
 - CIP B18027 damaged
 - Bridge and walkway look like they will collapse

 - Project was ready to bid, but it didn't get any qualifying bids
 - o LS Comment: hopefully to be started in January. Update the contract so more candidates can apply.
- Point Loma Ave. Access Stairs
 - PTS 680199 no access, in city plan check
 - Replace project stairs
 - Being funded by private development
- Sunset Cliffs Shoreline and Pocket Beach:
 - No access, no development proposals
